PROCEEDING OF ORDINARY MEETING OF THE BOARD TO BE HELD ON 24.06.2016 AT 11.00 HOURS IN THE OFFICE OF CANTONMENT BOARD AGRA.

167. **NOTING:**

To note consider resolution dt.08.6.2016 regarding issue of notice under section 320 CA 2006, in terms of order/judgment dt.18.5.2016 of the appellate authority.

RESOLUTION

167. Noted. Matter discussed at length. Dr. Pankaj Mahinderu demanded that responsibility should be fixed as to how the unauthorized construction was allowed to come up. Dr. Renu Mahinderu was of the opinion that a mechanism should be put in place to deter people from making unauthorized constructions. Board resolved that regular demolition drives should be taken to stop the ongoing unauthorized activities in the Cantonment. President Cantonment Board assured that full army support will be made available to the Cantonment administration in the matter CEO and Administrative Commandant should verify any encroachment and unauthorized construction in their area every 15 days and take necessary action for their removal/demolition.

168. AMC of HP Server of ABAS

Two HP Servers procured in May 2012, being used for live data entry of Accrual Based Accounting System (ABAS), is out of warranty and is required to be put on comprehensive AMC. For the said purpose, contract proposal with rate quotation was asked from HP Company. The rate quoted by HP, as attached, is Rs. 2,48,317.34 (Two lakh Forty eight thousand three hundred seventeen and thirty four paisa only) including taxes for the comprehensive AMC of two servers.

The present cost of new single HP server with same configuration under DGS&D, as attached, is Rs. 2,03,085 (Two lakh three thousand eighty five only) excluding taxes. The warranty period for the same is 3 years. The delivery period for the same is 60 days.

Presently one motherboard and two RAM of one HP server is unserviceable and needs to be replaced by new part. The cost of replacement is approximately Rs. 1,10,000 (One lakh ten thousand only) as per present market rate.

The matter was pended by the Board for next Board meeting vide CBR No. 137 dated 28.04.2016. The present work of ABAS is being disrupted due to the unserviceability of one server and also the second **database** server can also become unserviceable at any time.

Also the work for centralization of ABAS is presently being done in cloud environment and will be tentatively completed within the current financial year 2016-17. After that the system of ABAS can be used only by client computers in DGDE-MPLS line.

In view of the above it is recommended to give the two server under AMC only for one year and make the server serviceable, so that ongoing project of ABAS can progress smoothly.

RESOLUTION

168. Considered and approved.

169. CONVERSION OF CANTONMENT IN TO SMART CITY:

To consider Principal Director DE, Central Command, Lucknow, letter No.56985/CDPs/ Cantt./2015, dt.25.05.2016 vide, which directions have been issued about conversion of Cantonment into Smart City.

All connected papers are placed on the table.

RESOLUTION

169. Considered and noted. Further resolved that to create a separate page for each ward for public utility services on Cantonment Board Web site and be accessible to every one. Further, for conversion of Cantt into Smart Cantt, water harvesting and soar plants be also planned in each ward. As a pilot project water harvesting and solar plants be installed in schools and hospitals. Solar lights be planned at central places.

170. REVISION OF MINIMUM RESERVE PRICE (MRP) IN RESPECT OF PARKING AT SADAR BAZAR

To consider and approve revision of minimum reserve price (MRP) in respect of parking at Sadar Bazar area to Rs 10 lacs per annum from Rs 15 lacs per annum.

2. Cantonment Board Agra has not been able to award parking contract at Sadar Bazar area besides repeated efforts. Cantonment Board has so far published E-tender notice thrice as per the details given below but none of the participant shown interest in the tender besides the fact that Cantonment Board has already revised parking rates almost double the previous rates vide CBR No. 99 dated 18.01.2016.

3. It is informed to the Board that parking contract at Sadar Bazar area could not be renewed post 16.9.2014 due to proposed beautification/developmental work in Sadar Bazar area by Agra Development Authority. Market Association of Sadar Bazar and Cantonment Board Agra were not in agreement on issues pertaining to parking and other developmental work in Sadar Bazar area. Market Association had staged protest against the proposed widening of Taj Road and shifting of parking to other adjoining sites. CMWP No. 35032 of 2015 before Hon'ble High Court Allahabad was filed by Shri Surender Singh Chauhan Secretary Taj Road Traders Association & another vs UOI & others.

RESOLUTION

170. Matter discussed at length. After deliberations Board resolved to publish etender notice on "Zero" MRP (Minimum Reserve Prize.)

171. ANNUAL ADMINISTRATION REPORT 2015-16:

171. Considered and approved. During the discussion Dr. PankajMahinderu gave his dissent. He submitted a letter signed by 5 Members. CEO to take necessary action as per rules.

172. <u>BUILDING PLAN/APPLICATION U/S 235 C.A.2006 IN RESPECT OF H.NO.</u> 369 (SY.NO.90 Part), KACHIPURA, AGRA CANTT.: BY SMT.SAVITRI GUPTA W/O SH.SATISH CHAND GUPTA:

Reference CBR No.15 dt.27.5.2014, vide which it was resolved to forward the building plans given by Smt.Savitri Gupta to DEO Agra Circle, Agra for NOC from land point of view, as required under section 283(3) of CA 2006. The building plans were

forwarded to DEO Agra Circle Agra under section 238(3) CA 2006, vide this office letter No.IX/369/BP/CE/2014/417 dt.01.7.2014. The office of DEO Agra Circle, Agra vide letter No.1/A/320/X, dt.25.7.2014, returned the building plans without giving NOC from land point of view. The said letter reads as under;

"As per record held with this office the subject survey no.90 is described as private land and not comes under the management of this office. The said land is near the Army establishment, so before issuing the sanction for building construction the guidelines of the Govt. of India, Min of Defence letter No.11026/2/2011/D(lands) dated 18th May 2011 (copy enclosed) may also be taken into consideration."

2. Accordingly, the building plan was sent to Stn. HQ, Agra Cantt for examination and comments/report on the said building plan vide this office letter No.53/Corpd./Stn. HQ/CE/2014/01 dt.29.12.2014. Certain information was sought by Stn. HQ, Agra Cantt. which was provided vide office letter No.53/Corpd./Stn. HQ/CE/2015/515 dt.31.8.2015 and No.53/Corpd./Stn. HQ/CE/2016 dt.22.4.2016. Stn. HQ, Agra Cantt vide letter No.585009/7/Q, dt.09.5.2016, returned the building plans. The said letter reads as under;

"The case for issue of NOC on the above subject has been examined in detail. Keeping in view the directions issued vide IHQ of MOD (Army) letter No.75003/Plg(Lands) dated 17 Sep 2015, (copy encl) NOC cannot be processed in this case as the distance of house from the Boundary wall of A-1 defence land is within the restricted zone. The applicant may be informed accordingly."

In view of the above, the building plan in respect of H.No.369, Kachipura, Agra Cantt is placed on the table alongwith all connected documents, for consideration of the Board. The Board may take decision accordingly.

Before the agenda was taken up for resolution, both interested parties i.e. Dr. Pankaj Mahinderu and Dr. Renu Mahinderu left the Board meeting.

187. Quarter No.09, Gwalior Road, (GLR Sy.No.321-B) Agra Cantt.

Reference CBR No.33 dt.27.05.2014 and Dte.Gen. DE, N,Delhi letter No.744/787/L/DE/CC/VIP/2014, dt.19.06.2015, and CBR No.126 dt.18.1.2016, regarding GLR Sy.No.321-B, Agra Cantt.

- 2. To consider Dte.Gen. DE, N.Delhi letter dt.19.06.2015 vide which directions have been issued by higher authorities to place the matter before Cantt Board with complete factual details alongwith fresh joint inspection report of CEO and DEO and examination of the lease conditions in order to ascertain change of purpose, addition/ alteration in building plan and other violation of lease conditions, if any. Dte. Gen. DE letter dt.19.06.2015 is reproduced as under;
- Para (2). As regard issue of unauthorized constructions done inside the premises of Qtr No.09, Gwalior Road, Agra Cantt, inputs given by the Central Command, CEO, Agra and joint inspection report of CEO and DEO Agra have been examined. The Dte Gen. has following specific observations on the subject matter.
- (i) The Cantt Board Agra vide CBR No.74 dated 12.09.2011 did not sanction the building plan dated 28.03.2011 submitted by S/Shri Karan Mahendru and Shiv Mahendru and instead revalidated the earlier sanctioned plan (sanctioned vide CBR No.328 dated 03.12.2004) for one year from 03.12.2011 to 03.12.2012 as a onetime measure. However, the applicant constructed building in accordance with the building plan of 2011 and not as per 2004 plan which is a clear violation of the Cantt Board Resolution.
- (ii) Further, the building plan of 2004 was regarding construction of roofs and walls of main building as well as outhouse/ servant quarters inside Qtr No.09. To the contrary, the applicants have constructed an entirely new building by demolishing the old structure which is also not in accordance with the sanctioned building plan.
- (iii) Though there is no increase in the existing plinth area, but there is a slight shift in the plinth of the new building for which the Board should have taken cognizance. This has not been done.

- (iv) The structure of the new building with changes in the interior walls are such that he building may not entirely by used for residential purposes and has potential to be used as a guest house or for commercial purposes. The aspect has been ignored by the Cantonment Board while considering the reply furnished by the applicants to the show cause issued by the Board vide letter dated 16.11.2013.
- (v) Legal opinion given by Shri Devendra Vajpayee, Cantt Board Legal Advisor on 16.01.2014 states the changes done in the building plan are of minor nature that are covered by the subsequent building plan submitted by the owners for sanction and that was considered by the Board. To the contrary, the Board had not given sanction to the building plan of 2011 and therefore, the opinion given by the CLA consist of factual inaccuracies that would have led him to give the said opinion.
- Para (3). In view of the foregoing, PD DE is requested to direct the CEO to place the matter in the next Board meeting with complete factual details along with the fresh joint inspection report of CEO and DEO which should clearly point out whether the bungalow is being used or intended to be used for any commercial purposes. While considering the matter, the Board should also refer to the lease conditions wherein it should be clearly pointed out that for any addition/ alteration in building plan or for any change of purposes etc, the lease conditions will strictly apply and in case of any violation thereof, immediate recommendations should be given by the Board to the DEO/PD DE for taking necessary action in the matter. The Board should be advised to examine the matter in greater detail by considering the lease conditions, provisions of Cantonments Act, 2006, land policy and building bye-laws of the Cantonment and then recommend or take suitable action in case any of the lease conditions are violated or the building is not constructed in accordance with the land policy of the Govt. or the building bye-laws of the Cantonment.
- Para (4). The action taken report should be forwarded to the Dte. Gen. within 30 days.
- 3. Accordingly as per DG's instructions, joint site inspection was carried out on 21.08.2015, as under
 - (i) As per record held in this office, the subject site falls in the GLR Sy.No.321-B, an area measuring 1.36 acres, described as Quarters No.9, classified as B-3 land under the management of this office in the devour of S/Shri Karan Mahindru and Shiv Mahindru both sons of Dr.Pankaj Mahindru. The land lord of the subject site is Govt. of India, held on lease up to 28.02.2026.
 - (ii) A per sanctioned building plan, building exists in the plan i.e. 65'-9" in the northern side and 56'-6" in the eastern side. But the building is not constructed as per sanctioned building plan.
 - (iii)During the inspection we measured the site as per sanctioned building plan dated 09th Sept. 2004 (vide Cantt. Board resolution number 328 dated 03.12.2004) and found that building was constructed 56'-6" in the northen side (in place of 65'-

9") and 65'-9" in the eastern side (in place of 56'-6"). In the southern side 9'-3" extended by making covered verandah, portion of hall room and portion of south-west room, as well as covered staircase with mumty, measuring 8'-3" x 19'-10", with overall height as 33'-1" unauthorisedly, within the extended portion measuring 9'-3" x 56'-6", i.e. 522.62 sq.ft. A brick wall was also constructed up to 3'-0" of height and 100'-0" long.

- (iv)As per sanctioned building plan, measurement of Block No.A i.e. 15'-0" in the northern side and 34'-0" in the eastern side. But at present Block A has been constructed 15'-3' in the northern side and 34'-6" in the eastern side. The area (0'-3" x 0'-6") has been extended in Block No.A.
- (v) As per sanctioned building plan, area of hall portion i.e. 46'-9" x 37'-9" but, at present, party hall portion has been converted into 6 rooms, 6 toilets and kitchen room.

As per local inquiry, it has came to the notice that subject bungalow site is being used as a guest house by the HOR of the property, which is change of purpose and unauthorized construction involved at site, but no encroachment and subdivision of site has been found. In this regard unauthorized construction shown in site plan is placed opposite with the inspection report.

Board may consider further action in the matter, in view of the joint inspection report of Cantt Board and DEO office.

RESOLUTION

187. Mr. Dilip Kanojia, Member Submitted a representation on behalf of Dr. Pankaj Mahinderu.

CEO explained the case to the Board members in hindi and informed the directions of DGDE, New Delhi received vide their letter No. 744/787/L/DE/CC/VIP/2014 dated 19 June, 2015 and the inspection report carried out by CEO/DEO in Mar 2016.

Matter was discussed at length and all the members present consented for action to be taken as per rules and notice be issued accordingly.

RESOLUTION: Considered & approved including for ladies.

At this point Shri Tariq Ahemad rejoined the meeting with the permission of the Board.

RESOLUTION: Considered and resolved that necessary action be taken in light of sources of ground water at site as per laid down procedure and also as per requirement on ground.

188.(3) Two Submersible pumps sets in each wards.

RESOLUTION: Resolved that necessary action be taken in light of sources of ground water at site and as per requirement on ground.

188.(4) 10 Handpumps be installed of each ward.

RESOLUTION: Matter discussed at length. Board resolved that views of Cantt. Engineer be taken in view of deceasing water table.

188.(5)05 urinals for public in each ward.

RESOLUTION: Considered and approved. including for ladies.

188.(6) 20 water stand post in each ward.

RESOLUTION: Considered and resolved that feasibility & requirement be checked in each ward. Resolved accordingly.

188.(7) 30 LED street light fittings each ward.

RESOLUTION: Board was informed that within the plan of Smart City, necessary step be taken in light of financial position.

188.(8) One overhead tank of 40,000 gallons in each ward.

RESOLUTION: Considered and resolved that Cantt. Engineer (East) to check the feasibility of work. Resolved accordingly.

188.(9) 05 community septic tanks in each ward.

RESOLUTION: Matter was discussed & approved Cantt Engineer to conduct a survey & put up report in the next board meeting.

188.(10)One cattle shed in each ward.

RESOLUTION: Discussed at point 188 (19)

188.(11)All primary schools be upgraded to Junior High School.

RESOLUTION: Matter discussed at length. Board resolved that necessary action be taken and present working Principal in Primary Schools to liaise with concerned authority for obtaining sanction of upgradation of School from primary to Junior High School.

188.(12)Two sulabh PGL's each ward.

RESOLUTION: Matter discussed at length. Cantt Engineer to conduct a survey and put up report in next Cantt Board meeting. During the discussion Shri Tariq Ahmad, elected member informed that ward No-5 one Sulabh PGL is now not working. Board resolved that necessary step be taken to restart the Sulabh PGL.

188.(13)Interlocking tiles work 20.00 lacs. Each ward.

RESOLUTION: It was explained to the Board that interlocking works will be undertaken once the contract is finalized.

188.(14)Drain repair work 15.00 lacs. Each ward.

RESOLUTION: It was explained to the Board that drainage works will be undertaken once the contract is finalized. Board further resolved that 25 extra man power be engaged for 89 days to clean the drains/nalas in the eve of rainy season.

RESOLUTION: It was explained to the Board that roads repair/recarpetting will be undertaken once the contract is finalized.

- E- Unauthorized construction is not involved.
- F- Sub-division of site is involved.

In view of the above mutation is recommended to be effective in favour of applicant for tax purpose only an area measuring 627 Sft.
